- 6. Will provide a monthly nutrition newsletter every month for families.
- 7. Facilitate parent meetings, as requested by centers.
- 8. The RD will meet quarterly with the Health and Nutrition Advisor, or designee, to coordinate effective services.
- 9. The RD will collaborate with center staff, as needed, to provide education and coordination.

10. The RD may be asked to review menus and consult on menu development.
